

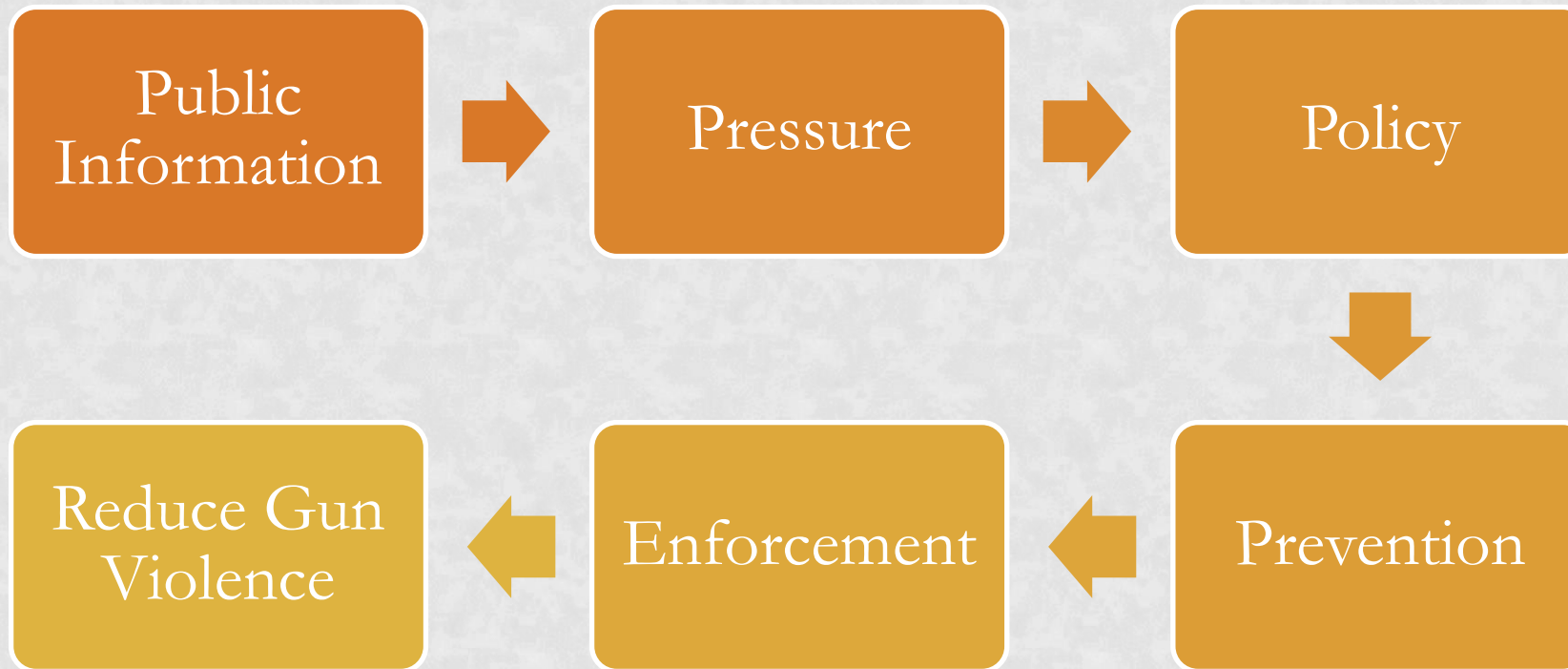

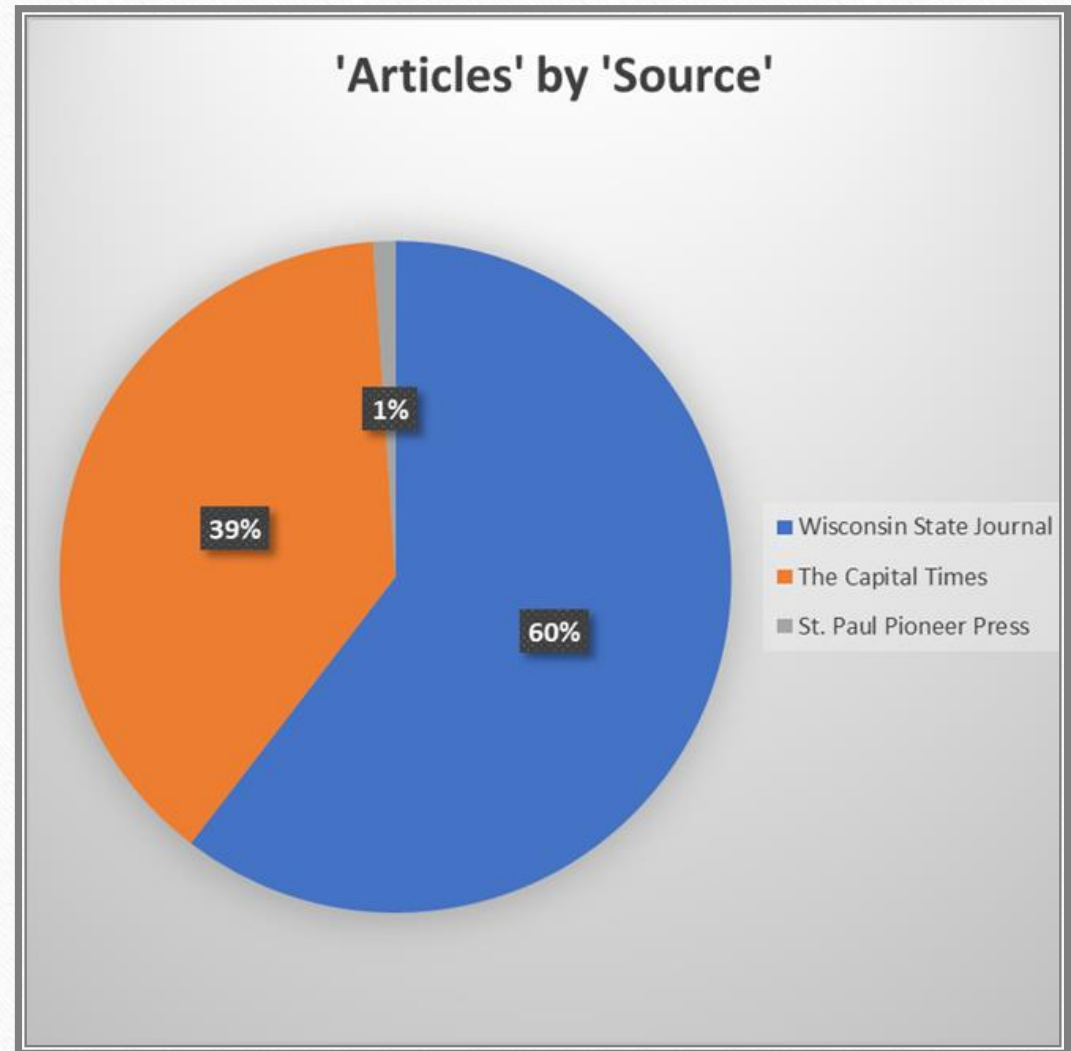

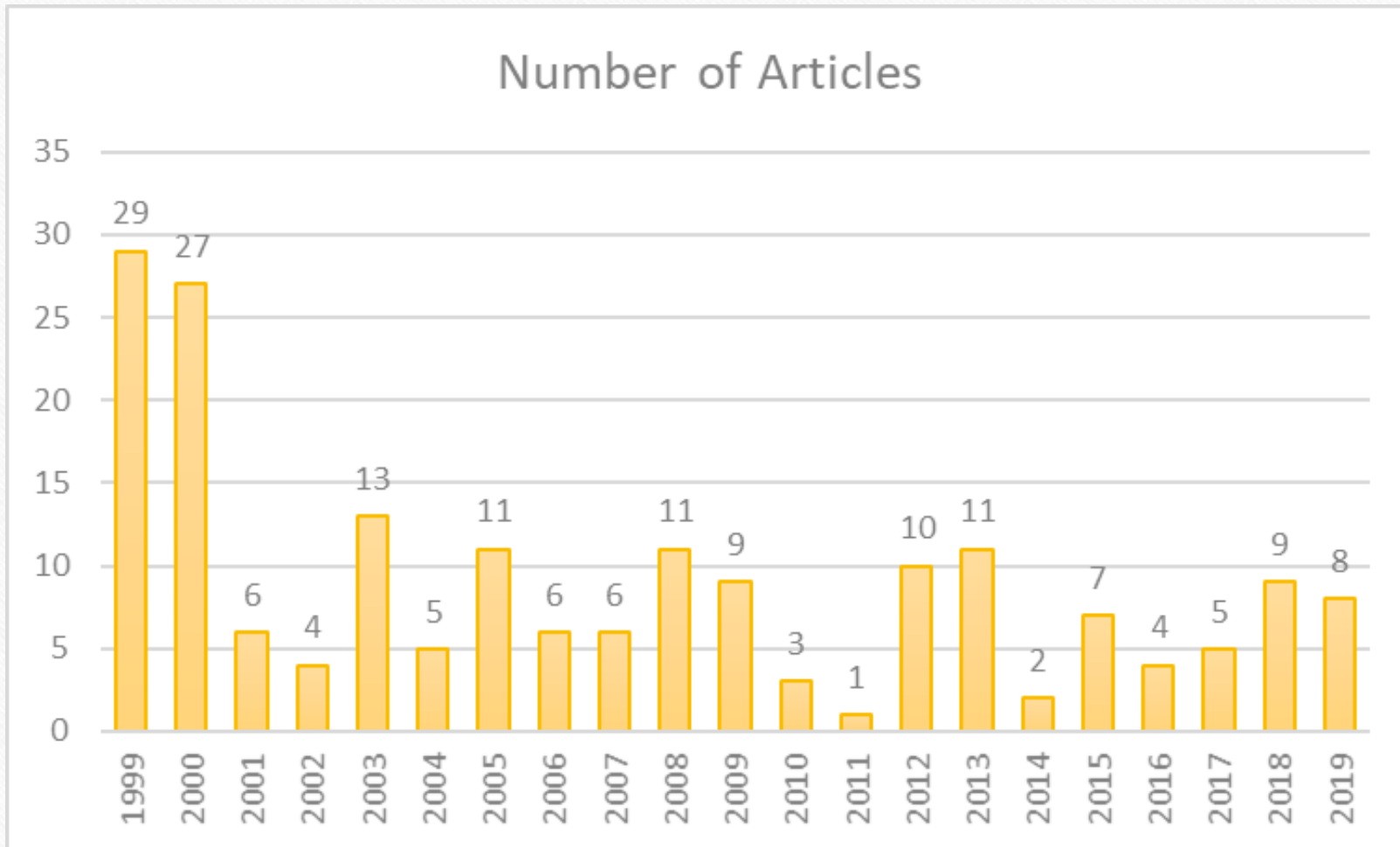

Media Coverage

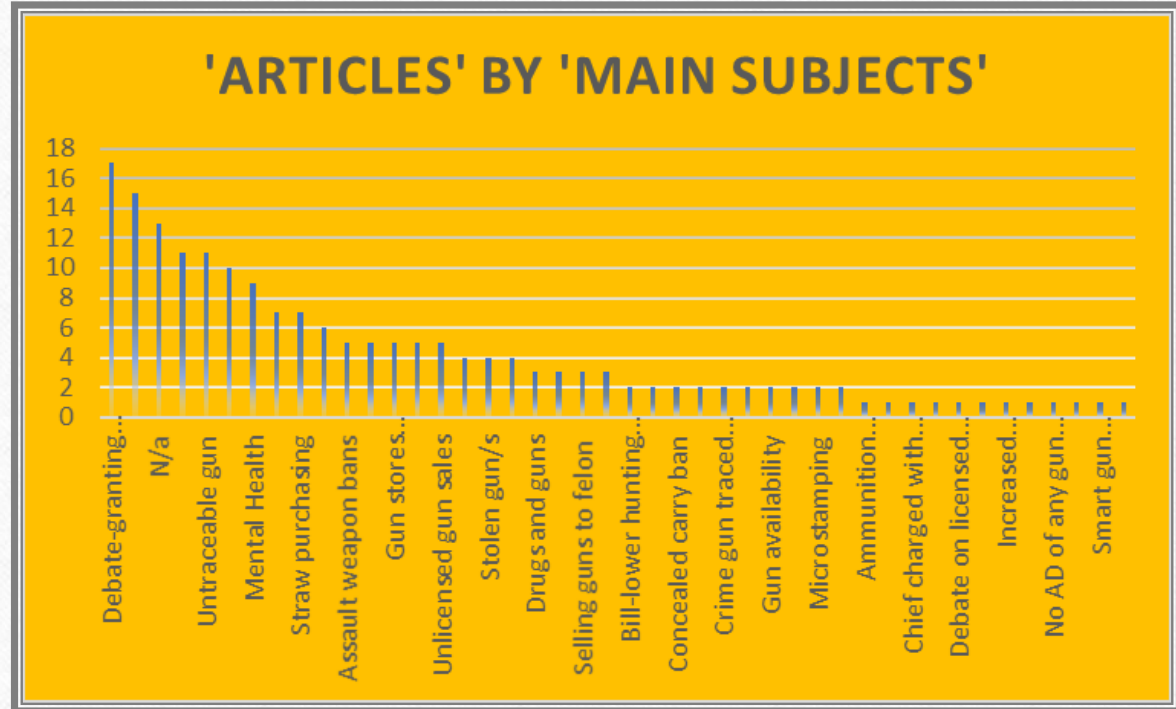
- No news sources from Racine, West Allis, Cheboygan...etc.
