Throughout the Education course sequences, pre-service teachers are taught to effectively integrate technology into curricula and instruction, to collect data, to manage data and to analyze data to improve teaching and learning. For example, in the course "Teaching Practice 1: Instructional Design and Teaching Models," students are taught to use technologies to enhance learning and assessment. This is just one example of how technology continues to be woven and integrated throughout the sequence of Education coursework. In addition, during their semester of student teaching experience, students must demonstrate their ability to adapt instruction based on data collection and analysis. Technology continues to be utilized in that process. We also use an online integrated platform to store and view videos in several other courses. Teacher candidates record lessons and receive feedback from peers, instructors, and supervisors.

Teacher candidates are also assessed in these areas again during their student teaching experience.

Consistent with Jesuit tradition, the College of Education programs at Marquette University prepare teachers, school counselors, counseling psychologists, community counselors and administrators to demonstrate a commitment to social justice through their work.
