  - Encourage the continuance of this fight


#### Current Work

## Future Steps

### Track Community Engagement

- What problems and solutions fall out of conversation?
- What problems and solutions gain traction?
- How does citizen engagement respond to environmental degradation?
- Develop network analytic approach to assess community engagement over time.

## Track Legal Proceedings

- Find comparative WI and US Supreme Court cases
- Find legal precedent to put in regulations for water run-off
- Create a timeline of resolved cases regarding farm water contamination

#### **Track Changes in Agricultural Practices**

• Does community engagement affect the likelihood of farmers adopting best management practices?

#### **Present to Activists**

- Go to Kewaunee County to show them our data
- Share findings with other clean water activists in Wisconsin and the greater Midwest
- Show successes, failures, and trials so that Kewaunee's steps can be replicated and perfected

#### Predicted Results

We are predicting that over time, citizens of Kewaunee will become more educated on the problems and solutions they are facing, leading to issues being brought to higher levels of government. Currently, the farthest citizens have gone is talking with city and county officials, and state legislators, but as this problem persists across the Midwest, there is a case to increase pressure on legislators, and even escalate to the federal congressional committees on agriculture. The problems of polarization will make citizens have to educate others in their local communities, so that individual farmers change their behavior.
